The Stopping up of Highways (Esless Lane, Rhostyllen, Clwyd) Order 1987

The Secretary of State for Wales hereby gives notice that he has made the above Order under section 209 of the Town and Country Planning Act 1971 to authorise the

stopping up of the highway described in the Schedule to this notice to enable development to be carried out.

The Order requires the provision of new roads and new footpaths, which shall be highways maintainable at the public expense, and for which Clwyd County Council shall be the highway authority. Copies of the Order may be inspected free of charge at all reasonable hours at the offices of Wrexham Maelor Borough Council, Rhostyllen House, Rhostyllen, near Wrexham, Clwyd.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act, or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 27th February 1987 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The highway to be stopped up is at Rhostyllen in the county of Clwyd and is that length of the unclassified road known as Esless Lane which extends from its junction with the Wrexham Road in a general northerly direction for a distance of 176 yards. (2 SI)
