- (b) the sale or offer for sale of goods from a vehicle will be prohibited, except on a Sunday, unless there is in force a valid license issued by the Tower Hamlets Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (c) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, will be prohibited.
- 3. The prohibitions referred to in paragraph 2 (a) and (b) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "orange badge" would apply.
- 4. A copy of the proposed Ordr, and of the Tower Hamlets (Waiting and Loading Restriction) Order 1976 (and of the Orders which have previously ammended that Order) can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date on which this notice is published in The Town Hall, Patriot Square, London E2 9LN.
