PROCLAMATION, Α

For Suspending the Execution of an Act. Intituled, An Act for Recruiting Her Maje/ty's Land-Forces and Marines, for the Service of the Tear One thoufand seven hundred and twelve.

Hereas by an All passed in the last Session of Qur prefent Parliament, Intituled, An Actific Recruiting Her Majesty's Land-Forces and Marines, for the Service of the Year One thousand seven hundred and twelve, it is, among other things, Englished, That the Commissioners by the faid All appointed for putting in Execution the Powers therein contained, or any Three or more of them, in their respettive Places or Stations, should Raife and Levy, and caufe to be Raifed and Levied, at any time or times after the respessive Days thereby appointed for the second Meeting of the said Com-missioners, and before the Eighteenth Day of March now next ensuing, such Able-bodied Men as do not follow or exercife any lawful Calling or Employment, or have not fome other lawful and fufficient Support and Maintenance, to ferve Us as Soldiers; and it is threby also provided. That when We should be Satisfied by the Returns of the faid Commissioners, or otherwise, That a sufficient Number of Recruits in the whole should be Raifed for OurService, We might by Our Proclamation suffer for Our Scrotte further Exe-sution of the said Ait: We being satisfied that at present there is no Occasion for Raising further Re-cruits for Our Service, have therefore thought fit, by and with the Advice of Our Privy-Council, to Issue forth this Our Royal Proclamation, and We do bere-by declare Our Pleasure to be, That the further Execution of that Alt be Suspended till We shall signific Our Pleasure otherwise : Of which the faid Commissioners, and all other Persons concerned in the faid Service, are bereby required to take Notice.

Given at Our Court at St. James's, the 8th Day of January, 1712. In the Eleventh Year of Our Reign.

W? E Tour Majesty's most dutiful and layal Sub-jedts beg seave, with the utmost Sense of Gratitude, bumbly to acknowledge Tour Majesty's great Condescension in communicating to Tour Par-liament the Terms on which a Peace may be made.

Advantageous to Great Britain, Just to Tour Alliet and Beneficial to Trade, which nothing but the Bleffing of God upon Tour Majesty's Princely Care, and the diligent application of Tour wise and pru-dent Ministry, could have so soon brought to pass, and as a sure Pledge of the same, with joyful Hearts, we see Tour Majesty possifiest of that important Fort of Dunkirk.

May God Almighty long preferve Tour Majefie to Reign over us, and enable Tou to finish and com-pleat this great Negotiation, which is so much wanted and defired by Yout Majesty's Subjetts; and that Tour Majesty may be blest with Success against Tour Enemies both at Home and Abroad, stall be the earnest Prayers of, may it please Tour Majest; Tour Majesty's most Loyal, most Obedient, most Dutiful Subjects and Servants.

Florence, December 27. N.S. On the 19th the Electoral Prince of Saxony arrived here. He was met at the Confines of this State by the Duke of Salviati, who conducted him into the Town, The next Morning the Great Duke went in Perlon to make him the first Visit, which he returned the fame Evening. It is thought he intends to continue here for some time, before he will let out for Rome, tho' Father Salerno, a Jeiuit, and another of the fame Order that attends him, are already gone thither to make Preparations for his Reception They write from Genoa, that the Marquis Grimalda is ape pointed by that Republick to gh Envoy Estraordi-nary to Rome, in order to adjuit their Disputes with that Court.

Hamburgh, January 13. N. S. Count Steinhock having received Intelligence at Segeberg that the Danes had laid up great Stores of Ammunition and Provisions at Altena, took a Refolution to change his Route, and marched towards that Place. When he arrived at Pinneberg, he went himfelf to true a view of the Danish Mingazine, and finding it was too confiderable to be brought off for want of fufficient Carriage, he ordered his Men to fet fire to the Place, which was accordingly done on the Ninth. and the whole Town burnt down to the Ground, Count Flemming and Monfleur Schölten immediately write a Letter to the Swedish General, desiring to know what Motives induced him to commit is great an Act of Barbarity. He returned Aniver; that his Reasons were too long for the compass of a Letter, but that in a flort time he would publish them to the World in Print. In the mean while he hath writ to Monfieur Wibe, Privy-Counfellor to the King of Denmark, to jultifie this Action by the neceffity he was under of committing it, and to complain of the great Devaltations the Czar's Forces had made in Pomerania, which he declares is an Example he would not have follow'd, if he had not been compelled to it by the Extremity of the War. been compelies to it by the Extremity of the war. On the Tenth the Swedes broke up from Pinne-berg, and encamped at Elmethorn, from whence they march'd the next Day to Itzehoë, and yefter-day they advanced to Gluckfizdt. Saturfaction to us, that after the the Allies, confilting, as is reported, of Thirty five Calamities of a long and expensive War, we have Batalions, and One hundred and eight Squadrons, such a vear Profpect of a Leace for Honourable and having crois'd the Butchy of Saxo Lawenbourg, is

approaching to the Confines of this City, and One [ thousand Mulcovites are already advanced as far as Ham and Horn, demanding Forage and Victuals of the Senate. Two Deputies are gone from hence to treat with Count Flemming about it. The Swedes in like manner begin to form Pretensions on us, and their Refident hath declared, that the King his Master must have a Supply equal to what was granted to his Danish Majesty. This Evening the Czar is expected at Bergdorff. When he received advice of the burning of Altena, and that all Holstein was threatned with the same Treatment, in case the Muscovites enter'd into it, he declared, that if Count Steinbock continued to act in that manner, he would order all the Swedes taken at Pultowa, beginning with the Counts Piper and Rhinffeld, to be hang'd up; befides which he would ravage all Pomerania with Fire and Sword. The Ele-Aor of Hanover hath forbid his Subjects to Trade or Correspond with this Town, for fear of the Flague.

Utrecht, January 17. N. S. Yesterday the Ministers of the Allies met in the Town-house, as usual, and in the Evening the Plenipotentiaries of France were for fome Hours in Conference with those of Her Majesty. Monsieur Marshal de Bieberstein arrived this Morning from the Court of Berlin, and has had a long Conference with the Earl of Strafford, by particular Orders from the King his Mafter. Letters of the 13th from Helvoet inform us, that the East of Peterborough was at that Place, from whence he intended to take the first opportunity of embarking for Great Britain.
