GLOUCESTERSHIRE COUNTY COUNCIL

The Gloucestershire County Council (Waiting Restrictions)
(Various Roads, Stroud and Rodborough) Order, 1987

Notice is hereby given that the Gloucestershire County Council have made an Order under the Road Traffic Regulation Act, 1984, the effect of which is:

1. To prohibit any vehicle from waiting at any time in parts of the roads specified in Schedule 1 to this Notice.
2. To prohibit any vehicle from waiting at any time between the hours of 8 a.m. and 6.30 p.m. in parts of the roads specified in Schedule 2 to this Notice.
3. To revoke the Traffic Orders specified in Schedule 3 to this Notice.

The Order contains exemptions to permit waiting for the purposes of boarding and alighting, loading and unloading, building operations or work on or under the length of road and in connection with the services of statutory undertakers. Exemptions will also apply to disabled persons' vehicles.

A copy of the Order which comes into effect on 23rd February 1987, together with the relevant plan, may be inspected during normal office hours at the Shire Hall, Westgate Street, Gloucester and the Stroud District Council Offices, High Street, Stroud.

Any person wishing to question the validity of the Order or of any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the ground that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order may within 6 weeks of the date on which the Order is made apply to the High Court for this purpose.

Residents Parking, Waiting Restrictions and Prohibition of
Waiting Tennyson Road/York Road Vicinity, Kettering
Experimental Order 1987

Notice is hereby given that the Administrative Council of the Borough of Kettering as agent for the Northamptonshire County Council propose to make an Experimental Traffic Order under sections 1(1), (2), 2(1), (2), 4(1), (2), sections 9(1)a, (2), (4), 10(2), 45 and 46 of the Road Traffic Regulation Act, 1984, the purpose of which will be for a general scheme of traffic control in a stated area being the area stated in Schedule 1 to the Order. The effect of the Order will be to designate areas of parking for resident permit holders only, areas where waiting is restricted to two hours and 30 minutes respectively and areas where waiting is prohibited and would apply to the lengths of road and during the hours specified in Schedules 2 to 8. The Order will be made for an initial period of 12 months.

Exceptions to the proposed Order will permit waiting for the purposes of removal of any obstruction to traffic and where necessary in connection with the maintenance of roads and the supply of gas, water and electricity and for emergency services. These exemptions will apply to disabled persons' vehicles bearing the relevant orange badge.

A copy of the proposed Order, together with a map showing the roads to which the proposed Order relates and a statement of the Council's reasons for proposing to make the Order, may be inspected at the offices of the Borough Solicitor between the hours of 9 a.m. to 12 noon and 2 p.m. to 4 p.m. Mondays to Fridays inclusive.

Objections to the proposed Order together with the grounds on which they are made should be sent in writing to the undersigned by 30th March 1987.

The Stated Area

The Area includes the following roads etc. namely Tennyson Road, York Road, Russell Street, Green Lane, St. Peter's Avenue and Gladstone Street.

SCHEDULE 2

Residents Only Permit Parking

- (a) *Tennyson Road*
 - (i) On the west side from a point 12.5 metres south of the junction with Green Lane for a distance of 66 metres in a southerly direction.
 - (ii) On the east side from a point 12.5 metres south of the junction with Green Lane to a point 6.8 metres north of the junction with St. Peter's Avenue.
- (b) *York Road*
 - (i) On the west side from a point 6.8 metres north of the junction with St. Peter's Avenue for a distance of 62 metres in a northerly direction.
 - (ii) On the east side from a point 11.9 metres south of the junction with Green Lane for a distance of 69 metres in a southerly direction.
- (c) *Green Lane*
 - (i) On the north side from a point 8.5 metres west of the centre line of Tennyson Road to a point 14 metres east of the same centre line.
 - (ii) From a point 12 metres east of the centre line of York Road to the eastern-most end of Green Lane.
