Conditions attaching to Licence K

1. The product must be part of an adult traveller's luggage or contained within a postal package.
2. The product must not exceed 1 kilo in weight.

Notes attaching to Licence K

1. Where the product is contained within a postal package, a maximum of one kilo is permitted.
