### NOTICE OF APPLICATION FOR LICENCE TO OBSTRUCT OR IMPEDE THE FLOW OF AN INLAND WATER BY MEANS OF IMPOUNDING WORKS

Notice is hereby given that an application is being made to the Welsh Water Authority, S.E. Division, by The Nature Conservancy Council, Plas Gogerddan, Aberystwyth, Dyfed SY23 3EE for a licence to obstruct or impede the flow of a tributary of the Dulas Brook, between Buiith Road and Newbridge-on-Wye by means of hollows in the ground in the line of the existing course of water at map reference SO 018 556, in the Community of Disserth and Trecoed in the County of Powys.

The object of impounding water by means of the works is to create ponds for nature conservation.

#### COAST PROTECTION ACT 1949

### DYFED COUNTY COUNCIL

#### *The County of Dyfed (Mathry Hill, Mathry) (One-Way Traffic) Order 1987*
