DEVON COUNTY COUNCIL

The County of Devon (Queen Street and Gandy Street, Exeter) (Prohibition of Waiting, Loading and Unloading and Prohibition and Restriction of Driving) (Consolidation) Order 1987.

Notice is hereby given that Devon County Council propose to make an Order under the Road Traffic Regulation Act 1984 amending the provisions in respect of the prohibition of driving in Gandy Street, Exeter.

When the Order comes into effect, no vehicle will be allowed into Gandy Street, from its junction with Little Queen Street to a point 80 metres north-west of that junction, between the hours of 10.30 a.m. and 4.30 p.m. daily.
