

Notice is hereby given that on 26th March 1987 the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 23rd March, 1987 will be to prohibit the waiting by vehicles between the hours of 8 a.m. and 6 p.m. Monday to Saturday on Windmill Balk Lane, Woodlands from its junction with the eastern kerb-line of the Great North Road for a distance of 100 metres in a north-easterly direction.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

A copy of the Order and a map showing the restricted road may be examined during normal office hours at the offices of (i) the Director of Public Works, 15 South Parade, Doncaster and (ii) Woodlands Branch Library, Miners' Welfare Hall, Welfare Road, Woodlands, Doncaster.

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 26th March 1987 apply to the High Court for this purpose.

##### *Traffic Regulation Orders*

Notice is hereby given that the Gosport Borough Council, as Agents for the Hampshire County Council, propose to make the following Orders under sections 1(1) and (2), 2(1) to 3 and 4(2) of the Road Traffic Regulation Act 1984 as follows:

(1) *Borough of Gosport (Holly Street/Oak Street/Stoke Road) (Prohibition of Waiting at any Time) (No. 2) Order 1987*

*Holly Street*, the whole of Holly Street except within the lay-by and parking areas.

*Oak Street*, the whole of Oak Street including the turning head.

*Stoke Road*, the north side from a point 15 metres west of Oak Street to the Bus Stop Clearway Area east of Oak Street.

(2) *Borough of Gosport (Eastbourne Avenue/Hastings Avenue) (Prohibition of Waiting at any Time) (No. 3) Order 1987*

*Eastbourne Avenue*, to extend the existing restriction on the north side from its junction with Brockhurst Road to a point east of Hastings Avenue (outside No. 19).

*Hastings Avenue*, both sides from its junction with Eastbourne Avenue in a northerly direction for a short distance (15 metres).

Exemptions to the Orders will permit waiting for certain purposes including:

- (a) Picking up and setting down of passengers.
- (b) Loading and unloading of goods.
- (c) Building operations road and similar works.
- (d) The Disabled.

Copies of the Orders and relevant Maps showing the lengths of road concerned together with the Council's reasons for making the Order may be inspected at the office of the undersigned during usual office hours.

Objections to the proposals should be sent in writing, stating the grounds thereof, to the undersigned by 17th April 1987.

##### *The Gwent County Council (High Street, Raglan) (Restriction of Waiting) Order 1987*
