- 1. This Order shall come into operation on 1st April 1987 and may be cited as The Hartlepool Borough Council (Stockton Road) (Restriction of Waiting) Order 1987.
 - 2. (1) In this Order:
 - "bus stop area" means any area of carriageway on either of the sides of the road or in the lengths of road specified in the Schedule to this Order intended for the waiting of buses which is comprised within and indicated by a road marking complying with either diagram 1025-1 or diagram 1025-3 in Schedule 2 to the Traffic Signs Regulations and General Directions 1981 as amended:
 - "disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1982;
 - "disabled person's vehicle" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1971 as amended by the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975.
- (2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position when:
 - (a) in the case of a vehicle fitted with a front windscreen the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen and
 - (b) in the case of a vehicle not fitted with a front windscreen the badge is exhibited in a conspicuous position on the front or near side of the vehicle.
- (3) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

- 3. Save as provided in Articles 4 and 5 of this Order no person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to wait between the hours of 7 a.m. and 7 p.m. on any day other than a Sunday in the length or side of the road specified in the Schedule hereto.
- 4. (1) Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides of the road or in the lengths of road referred to therein for so long as may be necessary to enable:
- (a) a person to board or alight from the vehicle;
- (b) goods to be loaded onto, or unloaded from, the vehicle;
- (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said sides of the road or lengths of road;
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, the said sides of the road or lengths of road of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878;
