NOTTINGHAMSHIRE COUNTY COUNCIL

The Nottinghamshire County Council (Plains Road and Woodborough Road, Arnold/Carlton) (Prohibition of Waiting) Order 1987.

Notice is hereby given that the Nottinghamshire County Council has made an Order under section 1 of the Road Traffic Regulation Act 1984, as amended, the effect of which will be that vehicles will be prohibited from waiting at any time in the following lengths of road at Arnold/Carlton in the Borough of Gedling:

- (1) Plains Road, north-west side, from a point 28 metres south-west of its junction with Gretton Road in a south-westerly direction to its junction with Bonington Road;
- (2) Woodborough Road, south-east side, from a point 85 metres south-west of the centre line of Westdale Lane in a south-westerly direction for a distance of 23 metres.

The existing peak period prohibitions of loading and unloading will continue. There will be consequential amendment of existing Traffic Regulation Orders.

The usual exemptions will be provided. Relevant documents may be inspected at my Office or at the Library, 454 Westdale Lane, Mapperley. Any person wishing to question the validity of the Order or any of the provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act
