

11. Bridle road No. 426 which runs from Rosemary Lane at the junction of bridle road Nos. 424 and 425 north-east of Spout Fold Farm in a southerly direction for a distance of about 215 metres to its junction with bridle road No. 427 and footpath No. 435.

12. Footpath No. 435 which runs from its junction with bridle road Nos. 426 and 427 south-east of Spout Fold Farm in a north-westerly direction for a distance of about 160 metres to its junction with footpath Nos. 434 and 443.

13. Footpath No. 434 which runs from its junction with footpath Nos. 435 and 443 south of Spout Fold Farm in a generally north-westerly direction for a distance of about 75 metres to its junction with bridle road Nos. 433 and 438.

14. Part of footpath No. 423 which runs from Rosemary Lane at the junction with bridle road Nos. 425 and 433 on Rosemary Lane, north of Spout Fold Farm in a northerly direction for a total distance of about 400 metres to its junction with footpath Nos. 421 and 422, being that part which runs from its commencement for a distance of about 155 metres.

15. Footpath No. 444 which runs from its junction with footpath Nos. 397 and 428 north-west of Leadbeater's Farm in a south-easterly direction for a distance of about 70 metres to its junction with footpath Nos. 399 and 402.

16. Footpath No. 402 which runs from its junction with footpath Nos. 399 and 444 at Leadbeater's Farm in a south-westerly, south-easterly then south-westerly direction for a distance of about 575 metres to its termination at the Borough boundary.

17. Footpath No. 429 which runs from its junction with footpath No. 428 and bridle road No. 431 east of the site of the former Ashes Farm in a south-westerly direction for a distance of about 85 metres to its junction with footpath Nos. 430 and 432.

18. Footpath No. 432 which runs from its junction with footpath Nos. 429 and 430 south of the site of the former Ashes Farm in a westerly direction for a distance of about 200 metres to its junction with bridle road No. 440 and footpath No. 441.

19. Footpath No. 441 which runs from its junction with bridle road No. 440 and footpath No. 432 at Mill's Brow in a westerly direction for a distance of about 230 metres to its termination at the Borough boundary.

20. Bridle road No. 427 which runs from its junction with bridle road Nos. 431 and 436 north of the site of the former Ashes Farm in a north-easterly direction for a distance of about 70 metres to its junction with bridle road No. 426 and footpath No. 435.

21. Footpath No. 443 which runs from its junction with bridle road Nos. 436, 437 and 440 north-west of the site of the former Ashes Farm in a northerly direction for a distance of about 130 metres to its junction with footpath Nos. 434 and 435.

22. Footpath No. 399 which runs from Back Lane at the junction of bridle road Nos. 396 and 398 due south of Lomax Brow in a south-westerly direction for a distance of about 280 metres to its junction with footpath Nos. 402 and 444 at Leadbeater's Farm.

23. Footpath No. 430 which runs from its junction with footpath Nos. 429 and 432 east of Mill's Brow in a south-westerly direction for a distance of about 250 metres to its termination at the Borough boundary.

24. Bridle road No. 440 which runs from its junction with bridle road Nos. 436, 437 and footpath No. 443 north-west of the site of the former Ashes Farm in a south-westerly direction for a distance of about 190 metres to its junction with footpath Nos. 432 and 441 at Mill's Brow.

Borough of Wigan

25. Footpath No. 51 which runs from its junction with footpath No. 402 at the Borough boundary north of Oliver Fold in a southerly direction for a distance of about 290 metres to Engine Lane.

26. Footpath No. 19 which runs from its junction with footpath No. 430 at the Borough boundary south-east of Mill's Brow in a southerly direction for a distance of about 220 metres to its junction with bridle road Nos. 14 and 18 on Engine Lane.

27. Rights of Way, comprising bridle roads Nos. 14, 18, 20 and footpath No. 52 which run coincident with Engine Lane from Shakerley Lane in a generally east-south-easterly direction for a distance of about 1.6 kilometres to Padiham Farm, being that part of bridle road No. 14 which runs from a point about 350 metres from its commencement to its termination; that part of bridle road No. 20 which runs from its commencement for a distance of about 260 metres and the whole lengths of the remaining bridle road and footpath.

28. Part of footpath No. 21 which runs from Engine Lane at the junction of bridle road Nos. 18 and 20 in a southerly direction to its junction with footpath Nos. 11, 22 and 23, being that part which extends to the boundary of the land 70 metres from its

commencement and recommences at the boundary of the land immediately south of the Wigan to Atherton and Manchester railway to its termination.

29. Footpath No. 22 which runs from its junction with footpaths Nos. 11, 21 and 23 at the rear of Cornwall Avenue in an easterly direction for a distance of about 570 metres to its junction with footpath Nos. 47 and 48.

30. Part of footpath No. 48 which runs from its junction with footpath Nos. 22 and 47, west of Common Fold in a generally north-easterly direction for a total distance of about 140 metres to Cumbermere Lane, being that part which runs for a distance of about 50 metres.

31. Part of footpath No. 47 which runs from its junction with footpath Nos. 22 and 48, west of Common Fold in a south-easterly direction for a total distance of about 150 metres to Cumbermere Lane, being that part which extends for a distance of about 40 metres.

32. Rights of way, comprising bridle road Nos. 49, 45, 44, 43 and 42, which run coincident with Cumberland Lane from its junction with Engine Lane, north of Common Fold in a south-westerly direction for a distance of about 1 kilometre to Common Lane near Shakerley Old Hall, being that part of bridle road No. 44 which runs from a point about 10 metres from its commencement to its termination, the whole length of bridle road No. 43 and that part of bridle road No. 42 which runs from its commencement for a distance of about 220 metres.

33. Footpath No. 25 which runs from Cumbermere Lane at the junction of bridle road Nos. 43 and 44 south-west of Common Fold in a generally north-westerly direction for a distance of about 425 metres to its junction with footpath Nos. 24 and 26.

34. Footpath No. 46 which runs from Cumbermere Lane at the junction of bridle road Nos. 42 and 43 south-west of Common Fold in a south-easterly then north-easterly direction for a distance of about 310 metres to its junction with footpath Nos. 67 and 68.

35. Footpath No. 67 which runs from its junction with footpath Nos. 46 and 68 south-east of Common Fold in a generally north-easterly then south-easterly direction for a distance of about 110 metres to its junction with footpath Nos. 64 and 66.

36. Footpath No. 64 which runs from its junction with footpath Nos. 66 and 67 south-east of Common Fold in a south-easterly direction for a distance of about 275 metres to its junction with footpath Nos. 62 and 65.

37. Part of footpath No. 62 which runs from its junction with footpath Nos. 64 and 65 north of Cleworth Hall in a southerly direction to its junction with footpath Nos. 60, 61 and 63, being that part which runs from its commencement for a distance of about 210 metres.

38. Footpath No. 68 which runs from its junction with footpath Nos. 46 and 67 south-east of Common Fold in a northerly direction for a distance of about 255 metres to its junction with footpath Nos. 72 and 87.

39. Footpath No. 87 which runs from its junction with footpath Nos. 68 and 72 east of Common Fold in a north-westerly direction to its junction with Cumbermere Lane.

40. Footpath No. 68A which runs from its junction with footpath No. 67 south-east of Common Fold in a north-westerly direction for a distance of about 100 metres to its junction with footpath No. 68.

41. Footpath No. 66 which runs from its junction with footpath Nos. 64 and 67 south-east of Common Fold in a northerly direction for a distance of about 240 metres to its junction with footpath Nos. 69 and 71.

42. Footpath No. 69 which runs from its junction with footpath Nos. 66 and 71 east of Common Fold in a north-westerly direction for a distance of about 80 metres to its junction with footpath Nos. 70 and 72.

43. Footpath No. 72 which runs from its junction with footpath Nos. 69 and 70 east of Common Fold in a westerly direction for a distance of about 20 metres to its junction with footpath Nos. 68 and 87.

44. Footpath No. 65 which runs from its junction with footpath Nos. 62 and 64 north of Cleworth Hall in a northerly direction for a distance of about 375 metres to its junction with footpath Nos. 71 and 78.

45. Footpath No. 71 which runs from its junction with footpath Nos. 65 and 78 due north of Cleworth Hall in a north-westerly direction for a distance of about 270 metres to its junction with footpath Nos. 66 and 69.

46. Footpath No. 70 which runs from its junction with footpath Nos. 69 and 72 east of Common Fold in a north-easterly direction for a distance of 250 metres to its junction with footpath Nos. 83 and 84.
