# HEREFORD AND WORCESTER COUNTY COUNCIL.

### The County of Hereford and Worcester (Various Streets, Hereford) Various Traffic Orders 1987

Notice is hereby given that Hereford and Worcester County Council propose to make the following Orders on various roads in the City of Hereford in the County of Hereford and Worcester under sections 1(1) and (2), 2(1) to (3), 3(1), 4(1) and (2), 32, 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers:

1. (St. Owen's Street, Offa Street, St. Peter's Square, Gaol Street and Delinguent's Passage, Hereford) (Prohibition of Waiting) Order 1987

To prohibit waiting at any time on the sides of lengths of roads specified in the First and Second Schedules to this notice. Exemptions in the Order will permit waiting for the purposes of picking up and setting down passengers; loading and/or unloading goods (applies to First Schedule only); delivering and collecting mail by Post Office vehicles; delivering and collecting furniture and effects with police consent; any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply of gas, electricity and water and maintenance of any telecommunications apparatus; the fire brigade, ambulance or police services; the pursuance of statutory powers or duties (if no other road can conveniently be used). An exemption in the Order also permits the waiting by disabled persons' vehicles displaying a badge issued under the Local Authority's

"orange badge" scheme for a limited period of 2 hours, return prohibited within a further period of 1 hour (applies to First Schedule only).

2. (St. Peter's Street, High Town and Commercial Street, Hereford) (Prohibition of Driving) Order 1987

(i) To prohibit any vehicle from proceeding or waiting in the roads and length of road specified in the Third Schedule to this notice on Monday to Saturday inclusive before 10.30 a.m. and after 4.30 p.m., and all day Sunday.

Exemptions to the Order will be allowed to the fire brigade, ambulance or police services; the pursuance of statutory powers or duties (if no other road can conveniently be used); any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply of gas, electricity and water and maintenance of any telecommunications apparatus; road cleansing; delivering and collecting mail by Post Office vehicles; security vehicles being used in connection with providing a security service for the benefit of owners and occupiers of land or premises fronting the said roads and length of road; requiring access to land or premises fronting the said roads and length of road; requiring access to land or premises fronting the said roads and length of road to which there is not a satisfactory alternative access; loading and/or unloading goods; pedal cycles and tricycles; a disabled person's vehicle displaying a disabled person's badge, and a parking disc, to gain access to the designated disabled persons parking places during the days and hours of operation of such parking places.

(ii) To prohibit any vehicle from proceeding or waiting in the roads and length of road specified in the Third Schedule to this notice between the hours of 10.30 a.m. and 4.30 p.m. on Monday to Saturday inclusive.

The exemptions set out in paragraph 2(i) above shall also apply except that vehicles requiring access to land or premises fronting the said roads and length of road to which there is not a satisfactory alternative access; loading and/or unloading goods; pedal cycles and tricycles and disabled person's vehicles displaying a disabled person's badge, and a parking disc, to gain access to the designated disabled persons parking places, during the days and hours of operation of such parking places, will not be excepted during these hours.

### 3. (St. Peter's Square and Union Street, Hereford) (Prohibition of Driving) Order 1987

To prohibit any vehicle from proceeding or waiting in the eastern arms of St. Peter's Square and Union Street which extend from the junction with St. Owen's Street for a distance of 50 metres (164 feet) in a northerly direction:

Exemptions to the Order will be allowed in respect of the fire brigade, ambulance or police services; the pursuance of statutory powers or duties (if no other road can conveniently be used); road cleansing; any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply of gas, electricity and water and maintenance of any telecommunications apparatus; requiring access to land or premises adjoining the said lengths of roads to which there is not a satisfactory alternative access.

4. (Commercial Street, Hereford) (Prescribed Route) Order 1987

To ensure that any vehicle proceeding in a north-easterly direction in Commercial Street makes a left-hand turn only into Blueschool Street.

5. (St. Peter's Square, St. Owen's Street, Gaol Street, Delinquent's Passage and Mill Street, Hereford) (One-Way Traffic) Order 1987

To prohibit any vehicle proceeding on the roads and lengths of roads specified in Column 1 of the Fourth Schedule to this notice in a direction other than that specified in Column 2.

An exemption in the Order exists for mechanical road cleansing vehicles.

## 6. St. Owen's Street and St. Peter's Square, Hereford (Street Parking Places) Order 1987

To authorise the parts of St. Owen's Street and St. Peter's Square specified in column 1 of the Fifth Schedule to this notice to be used free of charge, as a parking place for such vehicles or classes of vehicles, in such positions, on such days and during such hours as specified in relation to that part of the Schedule.

Provision is made subject to access not being unreasonably prevented in respect of the sides of lengths of roads specified in column 1 of the Fifth Schedule; the County Council's right to suspend parking in these streets to enable any street procession to take place or prevent obstruction or for any other appropriate reason; and the parking places not to be used in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skills or services.

# 7. (St. Owen's Street, Offa Street, St. Peter's Street and Commercial Street, Hereford) (Street Parking Places for Disabled Persons Vehicles) Order 1987

To restrict the parking of vehicles in the sides of lengths of roads specified in column 1 of the Sixth Schedule to this notice to those carrying disabled persons and displaying a badge issued under the Local Authority's Orange Badge Scheme.

Provision is made subject to access not being unreasonably prevented in respect of the sides of lengths of roads specified in column 1 of the Sixth Schedule; the County Council's right to suspend parking in these streets to enable any street procession to take place or prevent obstruction or for any other appropriate reason.

### 8. (Bath Street, Hereford) (Box Junction) Order 1987

To provide a "yellow box" marking in Bath Street which extends between its junction with Delinquents Passage and Symonds Street. No vehicle shall be driven into the boxed area and thereafter driven in such a direction that it becomes necessary, owing to the presence of stationary vehicles, for any part of the vehicle to remain at rest within the boxed area unless the driver of a vehicle is intending to turn and is prevented from doing so either by oncoming vehicles or by the presence of stationary vehicles provided it is waiting in a convenient position; the direction or with the permission of a police constable in uniform or of a traffic warden has been obtained; the vehicle is in use for police, fire brigade, or ambulance purposes; and the vehicle, the driver of which when entering the boxed area had reasonable cause to believe that he would immediately be able to drive the vehicle out of that area.

## 9. (St. Owen's Street and Gaol Street, Hereford) (Bus Lane) Order 1987

To establish bus lanes in the carriageways of St. Owen's Street and Gaol Street specified in the Seventh Schedule to this notice. Exemptions are contained in the Order for public service vehicles; vehicles used for the removal of obstructions to traffic (whether or not the obstruction is in the bus lane); the fire brigade, ambulance or police services; the pursuance of statutory powers or duties; road cleansing vehicles; the avoidance of an accident; disabled persons vehicles (when being used to gain access to premises on or fronting the bus lane);
