

AUTHORISED SCALE OF CHARGES FOR NOTICES  
FROM 1ST MAY, 1985

**Gazette Notice Charges include Value Added Tax at 15%**

- (a) Notices under the Bankruptcy Act, 1914, or the Bankruptcy Rules, 1952: the fee prescribed by the current Bankruptcy Fees Order.
- (b) Notices under the Companies Act, 1985.
  - (i) Notice of Appointment of Liquidator pursuant to section 600 of the Act and the Companies (Forms) Order, 1949 (S.I. 1949 No. 382); Notice of Advertisement of Petition pursuant to Rule 28 of the Companies (Winding-up) Rules, 1949 (S.I. 1949 No. 330): £13.23 (£11.50 + VAT).
  - (ii) Notice pursuant to the Companies (Department of Trade) (Amendment No. 2) Order 1979: the fee prescribed by the current Companies (Department of Trade and Industry) Fees Order.
  - (iii) Notices of Resolutions and Meetings of Creditors (sections 588-590): £35.36 (£30.75 + VAT).
  - (iv) Notices to Creditors and Final and Annual Liquidation Meetings of Members/Creditors: £47.84 each (£41.60 + VAT). Meetings of Members/Creditors are charged double rate when notice runs to twice normal length.
  - (v) Scottish sequestrations: £13.23 (£11.50 + VAT).
  - (vi) Other Companies Notices at the rates given under (i).

*Note.*

The charges under (b)(i) to (b)(v) are in respect of notices covering one company only. If notices include more than one company in the same group of companies, they will be charged as follows:

2 to 5 companies	—	double the single company rate
6 to 10 companies	—	treble the single company rate

- (c) Notices pursuant to the Friendly Societies Act, 1896 and the Industrial and Provident Societies Acts, 1965: £13.23 (£11.50 + VAT).
- (d) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: £26.05 (£22.65 + VAT).
- (e) Deputy Lieutenants Commissions: £17.48 for each Commission (£15.20 + VAT).
- (f) All Notices in the following sections will be charged in accordance with the set fees given below:
  - (i) Marriage Acts . . . . . £26.05 (£22.65 + VAT).
  - (ii) Partnerships . . . . . £43.53 (£37.85 + VAT).
  - (iii) Next of Kin . . . . . £26.05 (£22.65 + VAT)
  - (iv) Moneylenders Act . . . . . £35.36 (£30.75 + VAT).
  - (v) Water Resources Act . . . . . rates at (h) apply
  - (vi) Control of Pollution Act, 1974, Part II: up to 25 lines of printed matter. . . . . £57.50 (£50.00 + VAT)  
Thereafter rates at (h) will apply.
  - (vii) Road Traffic Regulation Act, 1984: up to 25 lines if printed matter. Thereafter rates at (h) will apply. . . . . £57.50 (£50.00 + VAT)
- (g) Notices pursuant to the Insolvency Act, 1985—sections 4 and 5. Authorisation of Insolvency Practitioners: £35.36 (£30.75 + VAT).
- (h) All Notices in the Public Notices section will be subject to a set fee of £70.27 (£61.10 + VAT) to be prepaid at time of insertion. For each additional 5 lines or under, above 35 lines, a further £7.90 will be charged plus VAT.
- (i) All other Notices or Advertisements, including Applications to Parliament, will be charged by the number of lines appearing in plain matter in the type of the Gazette:

If not exceeding 10 lines of printed matter: £25.59 (£22.25 + VAT).

For each additional 5 lines or under: £9.09 (£7.90 + VAT).

NOTE. Should it be necessary for a notice or advertisement to be reinserted owing to advertisers errors in the original, such reinsertion will carry a heading to the effect that it is a substituted notice or advertisement and the charge for this heading will be calculated at the rate given under (i). This does not apply if the heading appears before a notice or advertisement which has a fixed charge when the cost for such heading will be £9.09 (£7.90 + VAT).

All notices and advertisements should reach The London Gazette Office before 11.30 a.m. two days previous to publication except the Monday edition, for which notices must be received before 11.30 a.m. on the previous Thursday. Notices and advertisements received after that time will be inserted, or withdrawals or alterations effected, if circumstances permit, on payment of a late fee for each notice or advertisement at the following rates:

Up to 4 p.m. on the day previous to publication . . . . .	£9.09 (£7.90 + VAT).
Up to 10 a.m. on the day of publication . . . . .	£17.48 (£15.20 + VAT).

Neither late notices nor withdrawals can be accepted for the Monday or Wednesday Gazettes.

Notices which include column setting should reach The London Gazette Office at least one week prior to publication if possible.

The London Gazette is published every Monday, Tuesday, Wednesday, Thursday, and Friday except Public Holidays.

A voucher copy will be posted on the day of publication on prepayment of £1 (inclusive of postage).
