The Secretary of State for Transport hereby gives notice that he has made an Order under section S.209 of the above Act entitled "The Stopping up of Highways (County of Durham) (No. 4) Order 1987" authorising the stopping up of two areas of footway of Parliament Street (lying opposite to the Telephone Exchange) and an area of carriageway and footway of Parliament Street/Briton Terrace being on the southern side of those highways, in Consett, County Durham, to enable residential development consisting of the erection of 16 Aged Persons Bungalows to be carried out in accordance with planning permission granted by Derwentside District Council under Part III of the said Act.
