Bradford Road, Branch Road, Church Street, Crackenedge Lane Slip Road, Croft Street, George Street, Halifax Road, Leeds Road, Long Causeway, Mill Street West, Old Westgate, Railway Street Entrance/Exit, Railway Street, Wakefield Road, Webster Hill, Wellington Road, Wellington Road West and Wilton Street;

(vi) to impose 24-hour "Clearway" restrictions on lengths of Bradford Road, Branch Road, Church Street, Crackenedge Lane Slip Road, Croft Street, Dewsbury Ring Road, Halifax Road, Leeds Road, Longcauseway, Mill Street West, Old Westgate, Railway Station Entrance/Exit, Railway Street, Wakefield Road, Webster Hill, Wellington Road, Wellington Road West and Wilton Street.

(vii) to prohibit waiting by vehicles between 8 a.m. and 6.30 p.m. on Mondays to Saturdays on short lengths of Bradford Street and Greaves Road at their junction.
