

(1) To provide two designated loading bays on which waiting by vehicles (otherwise than for the purpose of loading or unloading goods) will be prohibited between 8 a.m. and 6 p.m. Monday to Saturday inclusive on the following lengths of roads:

(a) along the south side of the service road adjoining St. Mary's Way extending between its junctions with Green Street and Cumberland Street;

(b) along the west side of Cumberland Street extending between its junctions with High Street West and the service road to St. Mary's Way.

(2) To prohibit the driving of motor vehicles in that length of Green Street between its junctions with the service road adjoining St. Mary's Way and High Street West.

Full details of the proposals are contained in the draft Order which together with a map and a statement of the Council's reasons for proposing to make the Order may be examined during normal opening hours at the following:
