Notice is hereby given that the North Tyneside Metropolitan Borough Council proposes to make the above-mentioned Order under sections 45, 46, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The general effect of the Order if made will be to:

1. Introduce On Street parking with charges, 8.30 a.m. to 5.30 p.m.—Monday to Saturday (excluding Bank Holidays) in Howard Street, Norfolk Street, Bedford Street and Northumberland Square, North Shields and, details of the proposed new charges are contained in the Schedule to this Notice.
2. Abolish the present waiting restrictions in Howard Street, Bedford Street and Northumberland Square and replace the same by charged On Street parking as referred to in the Schedule below.
