## PUBLIC HEALTH ACTS AND CLEAN AIR ACT

### BRISTOL CITY COUNCIL

#### *The City of Bristol (No. 21) Smoke Control Order 1988*

Notice is hereby given that the Council of the City of Bristol in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956 as amended by paragraph 5 of the Second Schedule to the Local Government, Planning and Land Act 1980, propose to make an Order entitled "The City of Bristol (No. 21) Smoke Control Order 1988". The area covered by the proposed Order comprises the whole of, Hillfields and Frome Vale and parts of the Eastville and St. George West wards.

Subject to the exemptions provided by the proposed Order and by virtue of section 11(4) of the Act, if on any day after the Order has come into operation smoke is emitted from chimneys of any property in the Smoke Control area the occupier of that property shall be guilty of an offence and liable to a fine not exceeding £400 unless he proves that the emission was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, low volatile steam coals, coke and other carbonised fuels, gas and electricity.

After the Order has been made it will not come into operation before the expiration of a period of 6 months.

Copies of the draft Order may be inspected free of charge at the Council House, College Green, Bristol BS1 5TR, between 8.30 a.m. and 5 p.m. Monday to Thursday and between 8.30 a.m. and 4.30 p.m. on Fridays until 2nd October 1987 (at the Deanery Road Reception Area).

#### *The Ashford Borough (Park Street, Ashford) (Prohibition of Driving) Order 1987*

### ASHFORD BOROUGH COUNCIL

#### *The Ashford Borough (Various Roads, Ashford) (Restriction of Waiting) (Variation) Order No. 2 1987*

Notice is hereby given that the Ashford Borough Council as agents authorised by the Kent County Council have made the following Order on 30th July 1987, under sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 to come into operation on 10th August 1987.
