WHEREAS

(1) Pursuant to Section 652 of the Companies Act 1985, Inglelow Engineering Company Limited (Dissolved), (hereinafter called "the Company") became dissolved on the 20th August 1986.

(2) It is alleged that immediately before such dissolution the property disclaimed by this Notice was vested in the Company and may by virtue of section 654 of the Companies Act 1985 be deemed to have become bona vacantia and to have vested in the Crown.

WELSH OFFICE

The length of highway to be stopped up is at Clydach in the county of Gwent and is the verge on the western side of the carriageway of the highway known as Station Road which extends from a point 48 yards south-west of the junction of Station Road with the A465 from a general south-westerly direction to a point 46 yards north-east of Pant Glas Bridge, excluding a 2 metre wide strip at the side of the carriageway.

A6(M) Stockport North/South Bypass Reassessment of Carriageway Standards

In October 1985 the Department published draft Statutory Orders under the Highways Act 1980, providing for a new road from the Hazel Grove, Poynton boundary of the A523 to a junction with the M63/M66 at Brinnington. The road, which is known as the "Blue Route", is being planned to relieve severe congestion on the A6 in Stockport and Hazel Grove.

Since Order publication, there have been a number of revisions to Departmental Standards which set the design criteria for the Department's road schemes. The proposed A6(M) Bypass has now been assessed against the latest standards and as a result, the following changes to the carriageway provisions for the new road are proposed:

- (a) Between the diverted A6 at Hazel Grove and the A627 Offerton Road at Poise Brook, the road would be a four lane dual carriageway motorway (previously proposed as a three lane dual carriageway motorway.)

(b) Between the A627 Offerton Road and the interchange with the M63/M66 at Brinnington, the road would be a three lane dual carriageway motorway (previously proposed as a two lane dual carriageway motorway).

Except for the section of the road through the Bredbury Corridor, where there would be only marginal adjustments to the position and height of the retaining walls, the proposed width of the motorway would be increased by about 4 metres (13 feet) either side of its centre line. The fence line of the highway boundary would move a similar distance either side of the centre line, although its precise position would depend upon the topography of the area. As a result of the realignment of the northbound slip road onto the motorway at the A626 junction at Fogg Brook, an additional three properties at 3, 4 and 5 Brookdale Cottages, Holiday Lane, would need to be demolished. The owners and occupiers of these properties have been notified.

It is also proposed, (a) that the new length of diverted A6 between the proposed roundabout at the junction with the Bypass and the existing A6 Buxton Road to the east of the Bypass, should be built as an all purpose single carriageway road (previously proposed as an all purpose two lane dual carriageway) and, (b) that the existing A523 London Road North which would form the southern approach to the proposed roundabout at the junction of the Bypass with the A523, at Norbury Brook should remain as an all purpose single carriageway road (previously proposed to be upgraded locally to an all purpose two lane dual carriageway).

The new length of diverted A6 east of the Bypass would be reduced in width by up to 4 metres either side of its centre line. The improvements to the A523 London Road North would be reduced in width by up to 3 metres either side of its centre line, compared to previous proposals.

The draft Orders affected by the proposed revised standards are:

- (i) The A6(M) Motorway (Stockport North-South Bypass) and Connecting Roads (Side Roads) Order 198 .
- (ii) The A6 Trunk Road (Hazel Grove Diversion) (Side Roads) Order 198 .
- (iii) The A523 Trunk Road (Hazel-Grove Diversion) (Side Roads) Order 198 .

The changes are minimal and cover alterations to highways and accesses affected by the construction of the scheme. Amended schedules to the Orders have been prepared and placed on deposit at the following locations:

 Cheshire County Council, County Hall, Chester CH1 1SF.

Amended plans showing the effects of the proposed changes will be prepared in time for the Public Inquiry which is expected to be held later this year.

A six week period is now being allowed for comment or objection to the proposed revisions. These should be submitted in writing to the Director (Transport), Departments of the Environment and Transport, North West Regional Office, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE, before 25th September 1987. Any comments received will be put before the Inspector taking the Inquiry so that he may be aware of the views expressed when making his recommendations to the Secretaries of State for the Environment and Transport.

OXFORD CITY COUNCIL

St. Clements—Traffic Regulations

Notice is hereby given that the Oxford City Council, with the consent of the Oxfordshire County Council, proposes to introduce on a permanent basis some of the traffic regulations in St. Clements which have operated on an experimental basis for the past 17 months. The Oxfordshire County Council has not approved the retention of the bus lane in St. Clement's Street and that will be removed.

In detail, the traffic regulations in St. Clements will be as follows:

- (1) a no-stopping clearway throughout the entire length of St. Clement's Street (and in London Place) including the 30-minute parking place in St. Clement's Street between 7.30 a.m. and 9.30 a.m. and between 4 p.m. and 6.30 p.m. on Mondays to Saturdays;
- (2) a 24-hour waiting prohibition throughout the entire length of St. Clement's Street except in the 30-minute waiting place (and also in London Place);
- (3) an on-street parking place on the south side of St. Clement's Street adjacent to the Almshouses with waiting permitted for periods of up to 30 minutes between 9.30 a.m. and 4 p.m. on Mondays to Saturdays;
- (4) a no-stopping clearway on the south-west side of Morrell Avenue between St. Clement's Street and Cross Street;
- (5) an on-street parking place on the south-west side of Morrell Avenue between Cross Street and London Place with waiting permitted for periods of up to 3 hours between 9.30 a.m. and 4 p.m. on Mondays to Saturdays.

The title of the Order which introduces these proposals is "The City of Oxford (East Oxford) (Parking Places and Traffic Management) Order 1987".
