Notification of New Substances Regulations 1982 Approval of a Code of Practice

The Health and Safety Commission ("the Commission"), with the consent of the Secretary of State for Employment, on 27th July 1987, approved the Annex to Commission Directive 84/449/EEC specifying test methods for determining the ecotoxicity, physicochemical properties and toxicity of new substances as a code of practice. On the same date the Commission withdrew its approval from the Codes of Practice numbered COP 8, 9 and 10. The approval and withdrawals have effect from 17th August 1987.

2. The code of practice gives practical guidance on the methods to be used in preparing the technical dossier required by the Notification of New Substances Regulations 1982 (S.I. No. 1496

amended by S.I. No. 1986/890).

3. The guidance in the Code is authoritative although failure to observe one of its provisions is not in itself an offence, the relevant part of the Code may be taken by the Court as proof of failure to comply with a requirement of the Regulation.
