##### *The Wandsworth (Prescribed Routes) (No. 4) Traffic Order 1987*

Notice is hereby given that the Wandsworth Borough Council on 7th August 1987 made above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985.

- (a) to revoke:
    - (i) the Wandsworth (Prescribed Routes) (No. 2) Traffic Order 1969;
    - (ii) the Wandsworth (Prescribed Routes) (No. 2) Traffic Order 1978;
    - (iii) the Wandsworth (Prescribed Route) (No. 3) Traffic Order 1978;
  - (b) to compel the right turn by vehicles from Bridgend Road into Jews Row;

##### *The Wandsworth (Waiting and Loading Restriction) (Amendment No. 32) Order 1987*

Notice is hereby given that the Wandsworth Borough Council on 7th August 1987 made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985.

2. The general effect of the Order will be further to amend the Wandsworth (Waiting and Loading Restriction) Order 1976 so that:

- (a) waiting by vehicles (other than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 1 to this notice;
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle will be prohibited:
  - (i) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 2 to this notice;
  - (ii) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in those lengths of streets specified in Schedule 3 to this notice;
- (c) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11 a.m. and 6.30 p.m. unless otherwise prohibited;
- (d) the sale or offer for sale of goods from a vehicle will be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Wandsworth Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
