- (e) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, will be prohibited;
- (f) any existing restrictions on the waiting by vehicles, on the sale of goods and on advertising activities in the lengths of streets specified in this notice imposed by the above-mentioned Order of 1976, will be revoked.
