Notice is hereby given that on 27th August 1987 the Derbyshire County Council made an Order under section 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

When this Order comes into effect on 31st August 1987 you will

When this Order comes into effect on 31st August 1987 you will not be allowed to leave your vehicle on the following lengths of road at Cromford:

No Waiting between the hours of 8 a.m. and 6 p.m.

Cromford Market Place, on the east side from its junction with the Trunk Road A6 for a distance of approximately one hundred and thirty yards.

Cromford Hill and Cromford Market Place (Wirksworth—Cromford Road, on the west side from approximately one hundred and thirty yards south of Barnwell Lane to the junction with the Trunk Road A6 on the east side from approximately one hundred and thirty yards south of Barnwell Lane to the junction with Bedehouse Lane.

Mill Road Cromford (also known as Lea Road), on the south side from its junction with the Trunk Road A6 for a distance of approximately one hundred and fifty six yards on the north side form its junction with the Trunk Road A6 for a distance of approximately forty six yards from a point approximately one hundred and three yards east of its junction with the Trunk Road A6 for a distance of approximately fifty three yards.

When this Order comes into effect on 31st August 1987, you will not be allowed to leave your vehicle on the following lengths of road at Buxton:

No Waiting at Any Time

St. John's Road (on the south side), from its eastern junction with Burlington Road in an easterly direction for a distance of 180 yards.

No Waiting at Any Time (Except for Invalid Carriages)

Road on the east side of the Town Hall (on both sides) from its junction with the Market Place north eastwards along its entire length a distance of approximately 60 yards.

No Waiting Between the Hours of 8 a.m. and Midnight

Windsor Road from its junction with Fairfield Road in an easterly direction for a distance of 15 yards.

Lightwood Road (a) on the south west side from its junction with Fairfield Road for a distance of 30 yards and (b) on the northeast side from its junction with Fairfield Road for a distance of 15 yards.

No Waiting Between the Hours of 8 a.m. and 6 p.m. from Monday to Saturday

High Street (on the east side) from its junction with South Street in a southerly direction to its junction with Dale Road. On the west side from its junction with Church Street to its junction with West Road.

West Road from its junction with High Street to its junction with Bath Road.

Green Lane on the south east side from its junction with London Road to its junction with Compton Road on the north-west side from its junction with Green Lane in a south-westerly direction for a distance of 15 yards.

Wye Street from its junction with Spring Gardens for a distance of approximately 41 yards.

Heath Street (a) on the south side from its junction with New Market Street to its western junction with Dale Terrace and (b) on the north side from its junction with Dale Terrace eastwards for a distance of 5 yards and (c) from its junction with New Market Street westwards for a distance of 10 yards.
