

Orders made by the Council listed in the Schedule hereto to be revoked, and declaring the whole of the area of the City of Birmingham to be a smoke control area.

Subject to the exemptions provided by the Order and by virtue of section 11(4) of the Clean Air Act 1956 as amended by section 1(2) of and Schedule 2 to the Local Government Act 1980, if on any day after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £400 unless he proves that the emission of smoke was not caused by the use of fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

The Order will come into force on 1st July 1988.

Copies of the proposed Order and of the map referred to therein may be inspected free of charge at the City Solicitor's Department, Paradise Place, Birmingham B3 3EH, at all reasonable hours during a period of 6 weeks from 21st September 1987.

Within the said period any person who will be affected by the Order may object to the making of the Order by writing to the City Solicitor (ref. LG/AB), Paradise Place, Birmingham B3 3EH.

##### *City of Birmingham Smoke Control Revocation (No. 1) Order 1987*

Notice is hereby given that on 21st September 1987 Birmingham City Council in exercise of the powers conferred upon it by the above-mentioned Act made an Order entitled the "City of Birmingham Smoke Control Revocation (No. 1) Order 1987" (hereinafter called "the Revocation Order") declaring the Smoke Control Orders listed in the first column of the First Schedule hereto having been made variously by the authorities listed in the Second Schedule hereto on the dates shown in the second column of the said First Schedule, to be revoked. The Revocation Order is about to be submitted to the Secretary of State for the Environment for confirmation.

The Smoke Control Orders listed in the First Schedule hereto will be superceded by the City of Birmingham Smoke Control Consolidation (No. 2) Order 1987.

The Revocation Order will not come into operation until 1st July 1988 or before a later date to be determined by the Secretary of State for the Environment.

Copies of the Revocation Order may be inspected free of charge at the City Solicitor's Department, Paradise Place, Birmingham B3 3EH, at all reasonable hours during a period of 6 weeks from 21st September 1987.

Within the 6 week period any person who will be affected by the Order may object to the confirmation of the Order by notice in
