COAST PROTECTION ACT

RHUDDLAN BOROUGH COUNCIL

COAST PROTECTION ACT 1949

Coast Protection (Notices) Regulations 1950

Notice is hereby given that the Rhuddlan Borough Council, acting in their capacity as coast protection authority, hereby give notice under subsection (1) of section 5 of the above Act that they propose to carry out coast protection work as described herein, between Barkby Beach, Prestatyn and Splash Point, Rhyl.

At Central Beach, Prestatyn, the work will consist of extending the profile of the existing stepped concrete revetment down to the existing beach level by asphaltic construction with a sheet pile toe over a 2,300 metre length. A similar profile utilising stone with a bitumen grout will be undertaken at Splash Point, Rhyl, over a 250 metre length. Between Barkby Beach, Prestatyn and the Rhyl boundary, beach management works will comprise the replacement of existing timber groynes with 13 No. 150 metre long rock groynes with beach replenishment. The area of foreshore involved at Prestatyn is shown between the points marked A and B at Rhyl between the points marked C and D on drawing R/87/58.

The overall programme of work is currently estimated to cost approximately £6.13 million and is likely to be undertaken in three

phases over a 6 to 7 year period at an average expenditure of £1 million per annum.

Any person who so wishes may, not later than 23rd October 1987, serve a written notice of objection to the above proposal on the Secretary of State and on the Council. Such notice must contain a statement of the grounds of objection and be sent by prepaid post to the Secretary, Welsh Office, Cathays Park, Cardiff, with a copy of the notice sent to the undersigned.
