The Secretary of State for Transport has prepared this draft compulsory purchase Order which he proposes to make. If made it will authorise the purchase of land which forms part of an open space as defined in the Acquisition of Land Act 1981, that is, land laid out as a public garden or used for the purposes of public recreation or a disused burial ground. This land is described in the First Schedule to this notice and is shown coloured pink on

the First Schedule to this holder and is shown coloured plan on the map referred to in paragraph 4 below.

The Order will be subject to special parliamentary procedure unless the Secretary of State for the Environment gives a certificate under section 19(1) of the Act. He has been asked by the Secretary of State for Transport to certify under section 19(1) (a) that he is satisfied that other land has been or will be given in exchange for the open space, which is not less in area and is equally advantageous to any persons entitled to rights of common or other rights and to the public, and that the land given in exchange has been or will be vested in the persons in whom the open space was vested, subject to the like rights, trusts and incidents as attach to the open space. The Secretary of State is required to give formal notice of his intention to issue a certificate before he reaches a decision, to give an opportunity for objections to be made.
