HIGHWAYS ACT 1980

*The (A64) Leeds-York-Scarborough Trunk Road
(Companthorpe Grade Separated Junction) (Trunking)
Order 198*

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under the section 10 of the Highways Act 1980 which will provide that the roads which he proposes to construct along the following routes shall become trunk roads as from the date when the Order comes into force:

- (a) four routes, two to connect the eastbound carriageway of the A64 Trunk Road to the A1237 Copmanthorpe Roundabout, and two to connect the westbound carriageway with the link road as described in Paragraph (b) below;
- (b) a 2-way link road, bridging the Trunk Road from the exit at the A1237 Copmanthorpe Roundabout in a southerly and westerly direction to its junction with the slip roads.
