Carlton) (Prohibition and Restriction of Waiting) Order 1987*

Notice is hereby given that the Nottinghamshire County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1984, as amended, the effects of which (respecting roads at Carlton in the Borough of Gedling) will be:

(1) Vehicles will be prohibited from waiting at any time (with peak period loading/unloading prohibition on Mondays to Fridays inclusive) in certain parts of the following road:  
*Carlton Hill.*

(2) Vehicles will be prohibited from waiting between 8 a.m. and 6.30 p.m. (with peak period loading/unloading prohibition on Mondays to Fridays inclusive) in part of the following road:

(4) Vehicles will be prohibited from waiting at any time in certain parts of the following roads:  
*Church Street, Burton Road, Station Road, Cavendish Road, Cavendish Drive, Foxhill Road East.*

(5) Vehicles will be prohibited from waiting between 8 a.m. and 6.30 p.m. in part of the following road:  
*Burton Road.*

(6) Vehicles will be allowed to wait for up to one hour (no return within following one hour) between 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive in part of the following road:  
*Cavendish Road.*

(7) Consequential revocation of existing restrictions.

The usual exemptions will be provided. Relevant documents may be inspected at my Office or at the Library, 341 Carlton Hill, Carlton, Nottingham. Written objections (stating grounds) must be received by me by 11th December 1987.

## CROYDON LONDON BOROUGH COUNCIL

*London Borough of Croydon**Revocation and Designation of Free Parking Places*

Notice is hereby given that the London Borough of Croydon on 20th November 1987 made the Croydon (Free Parking Places) (No. 1) Order 1987 under section 6 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

The general effect of the Free Parking Places Order will be to:

(a) revoke the designation by the Croydon (Free Parking Places) (No. 1) Order 1977 of certain free parking places on the highway and redesignate them with minor alterations in the highways listed in the Schedule to this Notice;

(b) provide that the parking places will be in operation between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);

(c) specify, in respect of the parking places, that passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles or invalid carriages may be left therein;

(d) provide that certain other vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.

A copy of the Order, which will come into operation for the purposes of the placing of traffic signs on 21st November 1987 and for all other purposes on 23rd November 1987 and of the Croydon (Free Parking Places) (No. 1) Order 1977 and of a map which indicates length of road to which the Order relates can be inspected until the end of 6 weeks from the date on which the Order was made during normal office hours on Mondays to Fridays inclusive at the Enquiry Counter, 6th Floor, Town Clerk's Department, Taberner House, Park Lane, Croydon.

Copies of the Order may be obtained from the Town Clerk's Department, Taberner House, Park Lane, Croydon.

Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

NOTE: The item referring to Cuthbert Road in our Notice dated 25th September 1987 has been withdrawn.
