- (ii) a vehicle being used to remove any obstruction; for purposes in connection with the statutory powers and duties of a local authority or the supply of gas, water or electricity or a telecommunications system provided that in all the circumstances it is reasonably necessary for the vehicles to enter the prohibited area.
- (b) to the prohibition referred to in paragraph 2 (a) (iii) in relation to a stage carriage, a scheduled express carriage, a school bus or a work bus;
- (i) with the permission or at the direction of a police constable in uniform;
- (ii) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

The Order provides that in pursuance of section 10(2) of the Road Traffic Regulation Act 1984 the Director of Engineering and Surveying of the London Borough of Newham for the time being or some person authorised in his behalf by him, if it appears to him or that person essential in the interests of expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by this Order runs, modify or suspend this Order or any provision thereof.

If the provisions of the Order continue in operation for a period of not less than 6 months, the Council will consider in due course whether the provisions of the Order should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1984. Persons desiring to object to the making of the Order under section 6 of the said Act of 1984 for the purpose of such reproduction and continuation in force may, with the afore-mentioned period of 6 months, send a statement in writing of their objection and the grounds thereof to the Director of Engineering and Surveying, 25 Nelson Street, East Ham, E6 4EH, quoting the reference E/TN/DJE/TM1/1.
