### GATESHEAD METROPOLITAN BOROUGH COUNCIL

#### THE CLEAN AIR ACT 1956

Notice of Intention to make the Borough Council of Gateshead Ryton/Crawcrook/Clara Vale (No. 35) Smoke Control Order 1988

Notice is hereby given that the Borough Council of Gateshead in exercise of the powers conferred on them by section 11 of the above mentioned Act, intend to make the Borough Council of Gateshead Ryton/Crawcrook/Clara Vale (No. 35) Smoke Control Order 1988 which will declare the area described in the Schedule hereto to be a Smoke Control Area.

Subject to the exemptions provided by the order and by virtue of section 11(2) of the Act if, on any day after the order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Copies of the Order and of the Map referred to therein may be inspected free of charge at the offices of the Director of Legal Services at Civic Centre, Regent Street, Gateshead at all reasonable times during the period of 6 weeks from 11th December 1987.

#### MIDDLESBROUGH BOROUGH COUNCIL

#### Amber Street, Prohibition of Waiting Order 1987

Notice is hereby given that Middlesbrough Borough Council acting as agents for Cleveland County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1984. When this Order comes into effect no person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden be allowed to leave their vehicle at any time on the length and sides of road specified in the schedule to this Notice.
