### SWALE BOROUGH COUNCIL

### SWALE BOROUGH COUNCIL

*Swale Borough Council (The Promenade, Leysdown)  
(Prohibition of Waiting) Order 1987*

Notice is hereby given that the Swale Borough Council pursuant to arrangements made with the Kent County Council in exercise of their powers under section 1 of the Road Traffic Regulation Act 1984, have made a Traffic Regulation Order.
