#### TENDERS FOR TREASURY BILLS

- I. The Folkestone-Honiton Trunk Road A35 Axminster Bypass

Street for a distance of 58 metres in a northerly direction

The effect of the City of Cambridge (Regent Street) (Cycling Lane) Order 1988 will be to (1) prohibit cyclists proceeding in a westerly direction and exiting from Regent Terrace and Parker's Piece turning left into Regent Street; and

(2) to introduce mandatory cycling lanes at all times on all days on the following lengths of Regent Street:

on its eastern side from the junction with Park Terrace for a distance of 35 metres in a southerly direction, and

on its western side from a point 7 metres from the northern boundary of No. 36 Regent Street for a distance of 55 metres in a northerly direction.

The reasons for introducing these Orders are (1) to prevent cyclists from turning across pedestrians who are crossing Regent Street whilst the traffic signals indicate that both cyclists and pedestrians have priority over the traffic along Regent Street.

Cyclists wishing to make this movement should dismount and complete the manoeuvre on foot, and

(2) to reduce the risk of accidents occurring on the approach to the combined cycle/pedestrian crossing by providing a cycle lane and

approaches free of parked vehicles.
