NOTICE OF PROPOSALS TO VARY LICENCES TO ABSTRACT WATER

Notice is hereby given that the Severn-Trent Water Authority (hereinafter called 'the Authority') whose head office is at Abelson House, 2297 Coventry Road, Sheldon, Birmingham B26 3PU, has formulated proposals for varying its Licence, Serial Number 18/54/3/179/G which authorises abstraction from underground strata (Triassic Sandstones) at Kinsall, by means of a borehole at National Grid Reference SJ 3505 3248 in the County of Shropshire.

The proposed variation is to include the Authority's existing source at Rednal, at National Grid Reference S 3697 2873 in the

Licence but with no overall change in the annual aggregate quantity to be abstracted at the two sources of 1,825,000 cubic metres. The variation will, however, allow increased abstraction at the Rednal source at rates not exceeding 1,800 cubic metres per day nor 657,000 cubic metres per year compared with existing rates of 1,398 cubic metres per day and 500,274 cubic metres per year.

Coincident with this variation, Licence No. 18/54/5/4814 which

currently authorises abstraction at the Rednal source (together with other abandoned sources at Lyneal, Tetchill, Hordley & Cockshutt)

will be revoked.

CONTROL OF POLLUTION ACT 1974

Notice is hereby given in accordance with section 36(1)(a) of the Control of Pollution Act 1974, that application has been made to the Secretary of State by South West Water Authority for consent to discharge a daily maximum of 1,236 cubic metres of final treated sewage and less than once a year an unspecified amount of emergency sewage overflow to the River Teign at NGR SX 8478 7709 and SX 8465 7716 (emergency overflow) from Chudleigh Knighton Sewage Treatment Works. This application relates to the following discharges:

(a) Full Treated Effluent

The current consent for this Works allows a dry weather flow discharge of 136 cubic metres per day. This application relates to the increase in sewage flows resulting from the predicted population growth to the year 2011 when the estimated dry weather flow discharge will increase to approximately 206 cubic metres per day.

(b) Emergency Overflow

This is an existing overflow which only operates in times of power failure to the works or in times of extremely heavy rainfall. It is proposed to improve the aesthetic quality of any effluent discharged by the provision of a bar screen to remove large solids.
