(c) To delete all references to the Daisy Meadow Car Park, Heybridge Basin, from the District of Maldon (Off-street Parking Places) Order 1976, and to vary Articles 6, 7, Schedules 1 and 3 of the said Order so as to enable the foregoing proposals to be brought into effect.
