Unless the Order is suspended or quashed as a consequence of any such application, any person who on 7th April 1988 has/had an interest in land having lawful access to a highway to which the Order relates may claim to be entitled to be compensated by the Mansfield District Council in respect of any depreciation in the value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on the Council at its above address within a period of 6 months from 7th April 1988 unless the period is extended in any particular case by the Secretary of State.

HIGHWAYS ACT 1980

The A6 Trunk Road (Market Harborough Bypass) Order 1988

The A6 Trunk Road (Market Harborough Bypass) Detrunking Order 1988

The A6 Trunk Road (Market Harborough Bypass Side Roads) Order 1988

The Secretary of State for Transport hereby gives notice that the proposes to make the following Orders:

1. an Order under sections 10 and 41 of the Highways Act 1980 which will provide that a road which he proposes to construct along a route of 7.23 kilometres in length north of Market Harborough in the counties of Leicestershire and Northamptonshire shall become a trunk road as from the date when the Order comes into force; and

2. an Order under sections 10 and 12 of the Highways Act 1980 which will provide that the length of the A6 trunk road to be superseded by the new trunk road mentioned above shall cease to be a trunk road as from the date on which the Secretary of State notifies the County Council of Leicestershire (who will become the highway authority responsible for that length within its County) that the said new trunk road is open for through traffic; and

3. an Order under sections 12, 14 and 125 of the Highways Act 1980 which will

(a) authorise him—

(i) to improve, raise, lower or otherwise alter highways.

(ii) to stop up highways,

(iii) to construct new highways,

(iv) to stop up private means of access to premises; and

(v) to provide new means of access to premises,

all north of Market Harborough aforesaid, on or in the vicinity of the route of the above mentioned new trunk road; and

(b) provide for the transfer of each of the said new highways to either the County Council of Leicestershire or the County Council of Northamptonshire (whichever is appropriate) as from the date on which he notifies that authority that they have been completed and are open for through traffic.
