### DEPARTMENT OF TRANSPORT

#### HIGHWAYS ACT 1980

*The Cheshire County Council (A534 Haslington Bypass Classified Road) (Side Roads) Order 1987*

The Secretary of State for Transport hereby gives notice that he has confirmed with modifications the above Order which was made by the Cheshire County Council under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, provides for authorising the council:

- (a) to carry out the improvement of highways;
- (b) to stop-up highways;
- (c) to construct new highways;
- (d) to stop-up private means of access to premises, and
- (e) to provide new means of access to premises;

all on or in the vicinity of the route of the classified road which the Council are proposing to construct at Haslington in the Borough of Crewe and Nantwich in the county of Cheshire from the existing roundabout junction of Hungerford Road (A532) and Crewe Road (A534) (at Crewe Green), to a new roundabout junction with the existing A534 Crewe Road in the borough of Conleton, approximately 1 kilometre north of Winterley.
