## TOWN AND COUNTRY PLANNING ACTS

### NEW FOREST DISTRICT COUNCIL

#### TOWN AND COUNTRY PLANNING ACT 1971, SECTION 277 (AS AMENDED)

##### *New Forest District Council the Designation of a Conservation Area at Lymington*

Notice is hereby given that the District Council of New Forest in pursuance of the powers conferred upon them by section 277 of the Town and Country Planning Act 1971 hereby cancel the designation of that part of Lymington which was designated as a conservation area on 23rd February 1977.

Notice is hereby given that under the power aforesaid the District Council of New Forest as Local Planning Authority have designated as a Conservation Area an area of land at Lymington in Hampshire. The designated conservation area includes all that land which was the subject of the previous conservation area and has been extended to include Wykeham House, land north of St. Thomas's Park, the Sports Ground, Parish Court and part of the Town Hall Car Park, together with houses in Emsworth Road, land north of Cannon Street, land between Waterloo Road and the railway line, houses and land either side of Bath Road, Part of the Bath Road boat compound and the Recreation Ground together with the Lymington Town Sailing Club and the Royal Lymington Yacht Club, Waterford, Stanley Road, Kings Saltern Road, part of Westfield Road, Withey Bed and land between Normandy Lane and Kings Saltern Road, Solent Mead, Grove Place and land to the east of Church Lane between Church Lane and Grove Gardens.

With very few exceptions, buildings within a Conservation Area may not be demolished except with the consent of the Local Planning Authority nor (again with very few limited exceptions) may trees be topped, lopped, felled, up-rooted or wilfully damaged or destroyed unless notice of proposed action has been given to the Local Planning Authority and permission to proceed has been received from them or they have failed to take conclusive action regarding the notice within 6 weeks from the time it was served. Trees already included in the Tree Preservation Orders are not subject to this procedure but are subject instead to the more stringent requirements of the appropriate Order.

A plan showing the precise extent of the Conservation Area is available for public inspection between the hours of 9 a.m. and 4.30 p.m. Mondays to Fridays at the Planning Department, Appletree Court, Lyndhurst, and at the Town Hall, Lymington. A copy of the plan will also be held by the Clerk to Lymington and Pennington Town Council.

#### NOTICE OF PUBLIC PATH DIVERSION ORDER TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

##### *The Borough of Rushmoor (Eastern Road, Aldershot) (Public Path No. 2 Diversion) Order 1988*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 6th May 1988, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Council of the Borough of Rushmoor as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way referred to in Part I of the Schedule below to a route described in Part II of the said Schedule more particularly described in the Schedule to the Order.

A copy of the Order and the map contained in it has been deposited at the Council Offices, Farnborough Road, Farnborough, Hampshire, where it may be inspected free of charge during normal office hours. Copies of the Order and map may be purchased.

Any representations or objections with respect to this Order may be sent in writing to the Borough Secretary, Rushmoor Borough Council, Council Offices, Farnborough Road, Farnborough, Hants, not later than 28 days from the date at the bottom of this notice and should state the grounds on which it is made.

If no representations or objections with respect to the Order are duly made, or if any so made are withdrawn, the Council may, instead of submitting the Order to the Secretary of State for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations or objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

#### SCHEDULE

##### *Part I. Route of Existing Footpath*

The 1.1 metre wide footpath running from Eastern Road, Aldershot, at the entrance to the former Perfectos Pipes and Concrete Works site in a north-easterly direction for a distance of 9 metres then a northerly direction for 64 metres. The footpath then follows an, east-north-easterly direction for 162 metres where it meets the River Blackwater at the Old Lane Bridge.

##### *Part II. Diverted Route of Footpath*

From the Old Lane Bridge referred to above at a width of 2 metres in a west-south-westerly direction for 16 metres, then 10 metres in a southerly direction to take up a route set back from and running alongside the River Blackwater for 121 metres. The route then travels in an east-north-easterly direction for 30 metres then west for 24 metres and south-west for 20 metres to Eastern Road.
