HIGHWAYS ACT 1980

The Aberystwyth-Llangurig Trunk Road (A44) (Capel Bangor Footways, Side Roads) Order 1988

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under sections 14 and 125 of the Highways Act 1980 which will:

(1) Authorise him:

- (a) to carry out the improvement of highways;
- (b) to stop up highways;
- (c) to construct new highways;
- (d) to stop up private means of access to premises, and
- (e) to provide new means of access to premises;

all at Capel Bangor in the Community of Melindwr in the County of Dyfed;

- (2) Provide for the transfer of the said new highways to the County Council of Dyfed as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

The Extinguishment of Vehicular Rights (Temple Street and Elusendy Crescent, Llanelli) Order 1988

The Secretary of State for Wales hereby gives notice that he has, on the application of Llanelli Borough Council, made the above Order under section 212 of the Town and Country Planning Act 1971 extinguishing, subject to some exceptions, any rights persons may have to use vehicles on the length of highway described in the Schedule to this notice.

Copies of the Order may be inspected free of charge at all reasonable hours at the Offices of the Borough Solicitor's Department, Llanelli Borough Council, Second Floor, Ty Elwyn, Town Hall Square, Llanelli.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1971; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act;

he may within 6 weeks of 15th July 1988 apply to the High Court for suspension or quashing of the Order or of any provision contained therein.

Any person, who at the time of coming into force of the Order, has an interest in land having lawful access to the length of the highway to which the Order relates shall be entitled to be compensated by the Llanelli Borough Council as the Local Planning Authority in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim for such compensation must be submitted to the Borough Council within 6 months of 15th July 1988.

SCHEDULE

(All distances are approximate)

The highways to which the Order relates are at Llanelli in the County of Dyfed and are:

(a) That length of highway known as Temple Street which extends from its junction with Elusendy Crescent in a general northerly direction for a distance of 1.8 metres.

(b) That length of highway known as Elusendy Crescent which extends from its junction with Temple Street in a general southerly direction for a distance of 16 metres.

(c) That irregular shaped piece of Elusendy Crescent situated to the west of the site of Electricity Sub Station (which is situated on the western side of Elusendy Crescent) comprising of a total area of 36.3 metres. (2 SI)

The Stopping up of Highways (Queen Street, Churchill Way and North Edward Street, Cardiff) Order 1988

The Secretary of State for Wales hereby gives notice that he has made the above Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of the areas of highway described in the Schedule to this Notice to enable development to be carried out.

Copies of the Order may be inspected free of charge at all reasonable hours at the offices of City Planning and Development Office, Cardiff City Council, Wood Street, Cardiff.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1971; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act,

he may within 6 weeks of 15th July 1988 apply to the High Court for suspension or quashing of the Order or of any provision contained therein.

The areas of highway to be stopped up are at Cardiff in the County of South Glamorgan and are 33 areas of highway which consist of 4 x 350mm² spots and 2 x 580mm² spots in North Edward Street, 6 x 350mm² spots in Churchill Way and 13 x 350mm² spots and 8 x 580mm² spots in Queen Street. (4 SI)

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

Pursuant to section 139(6) of the Customs and Excise Management Act 1979, and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts, certain goods namely a Mazda 929 motor vehicle, chassis number JM2HB121200506764 has been seized as liable to forfeiture by force of the following provisions namely:

- (a) Article 17(2) of Part 8 of the Customs Duty (Personal Reliefs) order 1970 in that the Commissioners are not satisfied (i) that you intended to depart finally from the United Kingdom within 12 months from the date of your entry on 20th September 1981, and (ii) that you were resident outside the United Kingdom.
