Proposed Smoke Control Area No. 23-Hendon/Grangetown

Notice is hereby given that the Council in the Borough of Siunderland in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, as amended, propose to make an Order entitled "The Sunderland (No. 23) Smoke Control Order 1988" declaring the area described in the Schedule thereto to be a Smoke Control Area.

Subject to the limitations and exemptions provided by the Order and by virture of section 11(4) of the Act, if on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £200 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels gas and electricity.

If confirmed the Order will not come into operation before the first day of March 1989 or before a later date determined by the Council.

Copies of the proposed Order and of the map referred to therein may be inspected, free of charge, at Room 3.2, Department of Administration, Town Hall, and Civic Centre, Sunderland and at Central Library, Borough Road, Sunderland during normal opening hours from the date hereof until and including 8th September 1988
