

HEREFORD AND WORCESTER COUNTY COUNCIL

The County of Hereford and Worcester (Findon Street and George Street, Kidderminster) (Prohibition of Waiting) Order 1988

Notice is hereby given that on 4th August 1988 Hereford and Worcester County Council made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, and of all other enabling powers, the effect of which will be to prohibit waiting at any time on the length and side of lengths of roads in the Town of Kidderminster in the District of Wyre Forest in the County of Hereford and Worcester specified in the Schedule to this notice.

The Order will come into operation on 16th August 1988.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, during normal office hours.

Any person who desires to question the validity of the Order, or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirement of that section or of Parts I, II or III of Schedule 9 to the Act of 1984, or of any regulations made under the said Part III of Schedule 9 has not been complied with in relation to the Order, may within 6 weeks of the date on which the Order was made (such date stated in this notice) make application for the purpose to the High Court.

SCHEDULE

Length and side of length of roads in the Town of Kidderminster in the District of Wyre Forest in the County of Hereford and Worcester.

1. *Findon Street*, both sides, from its junction with *George Street* for a distance of 15 metres (49 feet) in an easterly direction.

2. *George Street*, east side, from its junction with *Findon Street* for a distance of 10 metres (33 feet) in a southerly direction.

HEREFORD AND WORCESTER COUNTY COUNCIL

The County of Hereford and Worcester (C2182 Bridge Road, Cookley) (Prohibition of Waiting) Order 1988

Notice is hereby given that Hereford and Worcester County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, and of all other enabling powers, the effect of which will be to prohibit waiting at any time on either side of that length of C2182 Bridge Road in the Parish of Wolverley and Cookley in the District of Wyre Forest in the County of Hereford and Worcester which extends from a point 165 metres (541 feet) north of its junction with *Austcliffe Lane* for a distance of 256 metres (840 feet) in a northerly direction.

Exemptions in the Order will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and/or unloading goods;
- (c) delivering and collecting mail by Post Office vehicles;
- (d) delivering and collecting furniture and effects with police consent;
- (e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply and maintenance of any gas, electricity, water and telecommunications apparatus;
- (f) the fire brigade, ambulance or police services;
- (g) the pursuance of statutory powers or duties (if no other road can be conveniently used).

An exemption in the Order also permits the waiting by disabled persons' vehicles displaying a badge issued under the Local Authority's "orange badge" scheme for limited period of 2 hours, return prohibited within a further period of 1 hour.

Full details of these proposals are contained in the draft Order which together with a map showing the length of road affected and a statement of the Council's reasons for proposing to make the Order, may be examined from Monday to Friday during normal office hours at:

- (1) County Hall, Spetchley Road, Worcester.
- (2) Wyre Forest District Council Planning Department Offices, Land Oak House, Chester Road North, Kidderminster.

Objections to the proposal, giving reasons, must be sent in writing to the undersigned by 9th September 1988.

LANCASHIRE COUNTY COUNCIL

The Lancashire County Council (Lancaster Street, Coppull, Chorley Borough) (Weight Restriction) Order 1988

LINCOLNSHIRE COUNTY COUNCIL

Lincolnshire County Council (Battlefields Lane, Holbeach) (Restricted Roads) (Revocation) Order 1988

Notice is hereby given that the Lincolnshire County Council has made an Order under sections 82(2) and 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which is to revoke the existing 30 m.p.h. speed limit on the length of *Battlefields Lane, Holbeach*, extending from its junction with the new A17 Trunk Road north-eastwards for a distance of approximately 80 metres.

MANSFIELD DISTRICT COUNCIL

The District of Mansfield (Stockwell Gate) (Prohibition of Driving) Order 1988

Notice is hereby given that a notice of proposals in respect of the above Order appeared in the *Mansfield Chronicle Advertiser* and the *London Gazette* on 21st May 1987 and, as a result of objections received, a public inquiry is to be held in respect of the Order.

The effect of the Order will be to limit access to that section of *Stockwell Gate, Mansfield*, between *Queen Street* and *Rosemary Street* to those disabled badge holders who by reason of their disability are the keepers of vehicles which are exempted from road tax or who are in receipt of Attendance Allowance or Mobility Allowance, or who are over the age of 65 and who would receive
