ROAD TRAFFIC ACTS

Basingstoke and Deane Borough Council

A33 Reading Road, Popley Way, Crockford Lane Spur Road and Carpenters Down, Basingstoke

Notice is hereby given that the Basingstoke and Deane Borough Council proposed to make a Road Traffic Regulation Orders as follows:

Effect of Orders:

(a) To make permanent the Experimental Orders that have been in operation in respect of the following lengths of highway which have been closed to all vehicular traffic, including pedal cycles and mopeds since 9th March 1987:

A33 Reading Road, east side, deceleration lane and central reservation turning area opposite Popley Way.

Popley Way, east end at junction with and opposite the A33 Reading Road Central reservation turning area.

Carpenters Down, exit from Reading Road Roundabout.

(b) Vehicles prohibition from entering the central reservation on the A33 Reading Road located between the Popley Way and Carpenters Down junctions (near M.F.I.);

(c) Vehicles prohibited from proceeding in that length of the Crockford Lane Spur Road which extends from its junction with Crockford Lane (north/south length) to its junction with Carpenters Down, in a direction other than north-east to south-west.
