NEW TOWNS ACT 1981

Order for the Extinguishment of Public Rights of Way, Telford **Development Corporation**

WHEREAS (1) by virtue of section 23(1) of the New Towns Act 1981, the Secretary of State for the Environment (hereinafter called "the Secretary of State") may by order extinguish any public rights of way over land which has been acquired and is for the time being held by a development corporation for the purposes of the New Town Act 1981;

(2) the Telford Development Corporation has applied to the Secretary of State for an order extinguishing the public rights of way over the route described in the Schedule hereto and shown coloured red on the map, being rights of way to which the said Act applies;
(3) the Secretary of State has caused a notice to be published in

accordance with the provisions of section 23(2) of the said Act;

Now Therefore the Secretary of State in exercise of the power given to him in that behalf, hereby orders as follows:

(1) The public rights of way over the route described in the Schedule hereto and shown coloured red on the map shall be extinguished as from the date of this order.

other at the offices of the Secretary of State.
