Area of Special Protection-Berry Head, Devon

Notice is hereby given that on 17th August 1988 the Secretary of State for the Environment acting under section 3(1) of the Wildlife and Countryside Act 1981 made the Berry Head and Berry Head (Southern Redoubt) (Areas of Special Protection) (Amendment) Order 1988.

The Order which took effect on 26th August 1988 amends the Berry Head and Berry Head (Southern Redoubt) (Areas of Special Protection) Order 1984 by establishing a part of the coastal waters lying off Berry Head and the Southern Redoubt as an area of special protection for wild birds. The Order is reproduced in the annex to this notice. A map of the area concerned may be inspected free of charge at the offices of Torbay Borough Council, Town Hall, Torquay, Devon, or at the offices of the Department of the Environment, Room 9/08, Tollgate House, Houlton Street, Bristol, at all reasonable hours.

The Order makes it an offence for anyone, other than an authorised person or a person exercising any right vested in him whether as an owner, lessee, or occupier of the area concerned or by virtue of a licence or agreement, to intentionally:

(a) kill, injure or take any birds;

- (b) take, damage or destroy the nest of such a bird while that nest is in use or being built;
- (c) take or destroy an egg of any wild bird;
 (d) disturb any wild bird while it is building a nest or it is in, on or near a nest containing eggs or young; or
- (e) disturb dependent young of any wild bird.

Any person committing an offence within the area of special protection would be liable to a fine not exceeding Level 5 on the standard scale (currently £2000).

Citation, commencement and interpretation

1.---(1) This Order may be cited as the Berry Head and Berry Head (Southern Redoubt) (Areas of Special Protection) (Amendment) Order 1988 and shall come into force on 26th August 1988.

(2) In this Order, "the 1984 Order" means the Berry Head and Berry Head (Southern Redoubt) (Areas of Special Protection) Order 1984 (S.I. 1984/1471).

Amendments to the 1984 Order

2. The following amendments shall be made to the 1984 Order:

(a) in article 1(2), after the definition of "the Berry Head (Southern Redoubt) Area of Special Protection" there shall be inserted the following definition: ""the Berry Head (Coastal Waters) Area of Special

Protection" means the area specified in paragraph 3 of the Schedule hereto;"

(b) in article 1(2), after the definition of "the deposited map" there shall be inserted the following definition: ""the second deposited map" means the map marked "Map

referred to in the Berry Head and Berry Head (Southern

Redoubt) (Areas of Special Protection) (Amendment) Order 1988" and signed by an Under Secretary in the Department of the Environment, which has been prepared in duplicate and of which one duplicate has been deposited and is available for inspection at the offices of the Torbay Borough Council, and the other has been deposited and is available for inspection at

- the offices of the Secretary of State for the Environment." (c) in article 3, after the words "the Berry Head (Southern Redoubt) Area of Special Protection" there shall be inserted the words "or the Berry Head (Coastal Waters) Area of Special Protection":

 - "3. That part of the coastal waters lying off Berry Head and the Southern Redoubt shown coloured blue and edged on the second deposited map.'

Unless the Order is suspended or quashed as a consequence of any such application, any person who on 16th September 1988 has/had an interest in land having lawful access to a highway to which the Order relates may claim to be entitled to be compensated by the Bolsover District Council in respect of any depreciation in the value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on the Council at its above address within a period of 6 months from 16th September 1988 unless the period is extended in any particular case by the Secretary of State.
