HIGHWAYS ACT 1980

The London-Fishguard Trunk Road (A48) (Cross Hands Industrial Site Interchange, Slip Roads Trunking) Order 1988

may, within 6 weeks from 7th October 1988, or within 6 weeks from the date of publication of this notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Order, or of any provision contained therein.
