- 3. The prohibitions referred to in paragraphs 2(a) and (b) above will not apply to emergency service vehicles or to local authority vehicles being used in pursuance of statutory powers or duties.
- 4. The Order provides that, in pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Chief Engineer of the London Borough of Waltham Forest's Development Department for the time being or some person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs, modify or suspend the Order or any provision thereof.
- 5. A copy of the Order, which will come into operation on 14th October 1988, of the above-mentioned Order of 1977 (and of the Orders which have amended that Order), of the Waltham Forest (Prescribed Routes) (No. 1) Traffic Order 1985 (which is being amended in part to take into account the imposition of the prohibitions referred to in paragraph 2(a) and (b) above, and the Council's statement of reasons for making the Order can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 6 months from that date, at (a) the Information Desk, town Hall, Forest Road, Walthamstow, London E.17; and (b) the Reception Desk, Municipal Offices, The Ridgeway, Chingford, London E.4.

- 8. If the provisions of the Order continue in operation for a period of not less than 6 months, the Council will consider in due course whether the provisions of the Order should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1984. Persons desiring to object to the making of the Order under section 6 of the said Act of 1984 for the purpose of such reproduction and continuation in force may, within the aforementioned period of 6 months, send a statement in writing of their objections and the grounds thereof, to the Chief Executive, Town Hall, Forest Road, Walthamstow, London E17 4JF, quoting ref.
