(2) revoke the Traffic Regulation Orders specified in column 1 of Part III of the following table to the extent specified or referred to in column 2 of that Part of that table.

Part I. Waiting limited 8 a.m. to 6 p.m. Monday to Saturday to no longer than 30 minutes return prohibited within 1 hour.

Back St. Hilda's Terrace, (Unclassified county Road), south side, from a point 55 metres west of the centreline of Skinner Street westwards for a distance of 40 metres.

Part II. Waiting prohibited at all times with exemptions

Back St. Hilda's Terrace, (Unclassified County Road)

West and north sides, whole length.

- East and south sides, from its junction with A174 for a distance of 38 metres measured from the centreline of the A174.
- South side, from its junction with Skinner Street westwards for a distance of 55 metres measured from the centreline of Skinner Street.

South side, from a point 95 metres west of the centreline of Skinner Street westwards to the junction with the road known locally as Union Road, a distance of approximately 20 metres.
