### Extension of temporary direction withdrawing certain powers in relation to controlled drugs

In accordance with section 16(2) of the Misuse of Drugs Act 1971, notice is hereby given that the Secretary of State has, in accordance with section 15(6) of that Act, extended the period of operation of the following direction given in accordance with section 13 of that Act, which took effect on 21st September 1987, and was extended on 2nd November, 30th November, 28th December 1987, 25th January, 22 February, 21st March, 18th April, 9th May, 6th June, 4th July, 1st August, 29th August, and 26th September 1988, for a further period of 28 days commencing on 24th October 1988.

"The Secretary of State, in pursuance of sub-section (2) of section 13 and by virtue of section 15 of the Misuse of Drugs Act 1971, by this Direction prohibits Dr. John Roger James BM BCh, a doctor within the meaning of that Act, whose registered address is Somers Health Centre, Blackfriars Close, Somerstown, Southsea, from prescribing, administering and supplying and from authorising the administration and supply of any controlled drug within the meaning of that Act, which was, on 3rd September 1987, such a controlled drug, save and except the following:

(a) Any substance and products specified in Schedule 4 to the Misuse of Drugs Regulations 1985;

(b) Any preparation specified in Schedule 5 to the Misuse of Drugs Regulations 1985."

This direction does not extend to the doing of anything in circumstances in which it might lawfully be done without being a doctor.

# HEALTH AND SAFETY EXECUTIVE

### SPECIAL EXEMPTION ORDER

Changes in the legislation which restrict the hours worked by women and young people age under 18 employed in factories, introduced by the Sex Discrimination Act 1986, took effect on 27th February 1987, although the prohibition on women working at night remained in force until 26th February 1988. The provisions in the Factories Act 1961 and related legislation now apply only to young people. Section 117 of the Factories Act 1961 remains thereby enabling

the Health and Safety Executive (HSE), subject to certain conditions, to grant exemptions from these restrictions for young people aged 16 and 17 by making special exemption orders in respect of employment in particular factories. Orders are valid for a maximum of one year, although exemptions may be continued in response to renewed applications. During the quarter ended September 1988 the HSE granted or

renewed special exemption Orders relating to the employment of 4549 young persons. On the day of the count a grand total of 12679 young persons were covered by 1706 Orders. (18 SD)
