BIRMINGHAM CITY COUNCIL

Birmingham City Council (Various Roads, Birmingham) (Traffic Regulation) (Variation) (No. 2) Order 1988

Notice is hereby given that on 7th November 1988 the above-named Council made the above-named Order under sections 1(1) and (2), 2(1) to (3), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which, is to introduce new zigzag markings on the carriageway at the site of pelican crossings located at Chester Road, Birmingham Road, Golden Hillock Road, Church Road, Lickey Road, Dudley Park Road, Stoney Lane, High Street, Deritend, Station Road, Washwood Heath Road, Edgbaston Park Road, Highgate, Middleway, Edward Road and Brassington Avenue. DEVON COUNTY COUNCIL

(The County of Devon (Acorn Junction, Exeter) (Box Junction, One-way Street and Prohibition of Waiting) Order 1988

Notice is hereby given that Devon County Council propose to make an Order under sections 1(1) and (2), 2 (1)(3), 4(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984

In the Order "Acorn Link Road" refers to the unnamed link road leading from Magdalen Street approximately 80 metres east of its junction with Southernhay for a distance of approximately 165 metres southwards and westwards to its junction with Westernway and Holloway Street. "Eastern Link Road" refers to the unnamed link road leading Magdalen Street approximately 30 metres east of its junction with South Street for approximately 50 metres eastwards and southwards to its junction with the Acorn Link Road and Holloway Street.

When the Order comes into effect:

- (1) You will not be allowed to leave your vehicle at any time in the Eastern Link Road, both sides, for its entire length.
- (2) The following streets will become one-way in the direction indicated:

Acorn Link Road entire length, southwards and westwards. Eastern Link Road entire length, southwards.

Magdalen Street between South Street and Acorn Link Road, eastwards.

Holloway Street between Acorn Link Road and Magdalen Street, northwards.

(3) Box junctions will be provided at the following locations: Acorn Link Road with Eastern Link Road. Acorn Link Road with Holloway Street.

Acorn Link Road with Magdalen Street. Magdalen Street with South Street.
