### DEPARTMENT OF TRANSPORT

#### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Diversion of Highways (County of Kent) (No 1) Order 1988", authorising the diversion of the access road to Sparrow's Hall and of footpath AU5 on the Bockhanger Estate, Ashford, in the County of Kent.
