#### TENDERS FOR STERLING TREASURY BILLS

The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 25th November 1988 at 1 p.m. for sterling Treasury Bills to be issued under the Treasury Bills Act 1877 and the National Loans Act 1968, to the amount of £100,000,000.

The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the Tenderer on any business day from Monday, 28th November 1988 to Friday, 2nd December 1988, inclusive, and will be due 91 days after date.

The Bills will be issued and paid at the Bank of England.
Each Tender must be for an amount not less than £50,000

Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (Being a multiple of half of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

Notification will be sent on the day of the Tender to the persons whose Tenders are accepted in whole or in part. Payment in full of the amount due in respect of an accepted Tender must be made to the Bank of England by means of the Applier's draft navable through the Tenne Classics on by class. banker's draft payable through the Town Clearing or by cheque drawn on the Bank of England, not later than 1.30 p.m. on the day on which the relative Bills are to be dated and on which they are to be collected from the Securities Office.

Tenders must be made on the printed forms which may be obtained from the Securities Office, Bank of England.

#### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 209 and 216 of the above Act to authorise the stopping up of the lengths of all purpose highway and footpath detailed in the Schedule to this notice. This would enable the redevelopment of Crawley Town Centre (TC6) to be carried out in accordance with an application for planning permission that stands referred to the Secretary of State for the Environment in pursuance of an appeal under section 36 of the Act.

The proposed Order will require that lengths of new highway to be provided are to be highways maintainable at the public expense, for which the highway authority is to be West Sussex County Council.

During 28 days from 25th November 1988, copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Chief Executive and Town Clerk's Office, Crawley Borough Council, Town Hall, The Boulevard, Crawley, and may be obtained free of charge, from the Secretary of State (quoting reference RSE 5078/35/1/010) at the address stated
